# Resolution No. (4) of 2006

# For Granting a Telecommunications License to Emirates Integrated Telecommunication Company (Public Joint-Stock Company)

The Supreme Committee for the Supervision of the Telecommunications Sector,

having cognizance the Federal Law by Decree No. (3) of 2003, regarding the Organization of the Telecommunications Sector and its amendments, and

The Decision of the Supreme Committee for the Supervision of the Telecommunications Sector No. (3) of 2004 and its amendments on issuing the Executive Order of Federal Law by Decree No. (3) of 2003, regarding the Organization of the Telecommunications Sector, and

based on the presentation of the General Authority for Regulating the Telecommunication Sector and the approval of the Supreme Committee for the Supervision of the Telecommunications Sector,

it has been decided to:

## **Article One**

Award Emirates Integrated Telecommunications Company, a public joint-stock company (referred to hereinafter the "Company") the second license to establish, operate and manage a public telecommunications network and to provide the telecommunications services (as identified by the Federal Law by Decree No. (3) of 2003 regarding the regulation of the telecommunications sector) and to operate all the regulating activities.

#### Article Two

The General Authority for Regulating the Telecommunications Sector shall be designated to prepare the draft of the license terms awarded in accordance with the provisions of this decision and to submit it to the Supreme Committee for approval for issuance within a maximum period of 60 days from the date of this decision, provided that it shall include all the provisions that shall regulate the company's operations and activities such as:

- 1- Provisions related to the spectrum.
- 2- Provisions related to fees, for example: license acquisition fee, the annual fee to be paid by the licensee and other fees prescribed in the license that all shall be paid to the General Authority for Regulating the Telecommunications Sector.
- 3- Provisions related to financial fines which shall be considered as one of the license provisions and an implementation of the Law by Decree No. 3 of 2003. These fines shall be imposed on the licensee for violating the provisions of law or the Executive Order or the Regulatory Framework without prejudice to the provisions of Federal Law by Decree No. 3 of 2003 and it's Executive Order. The collected amounts of these fines shall be considered as revenue for the General Authority for Regulating the Telecommunications Sector.

The Company shall sign the licensing terms as approved and issued by the Supreme Committee in accordance with Article (2) of this decision, and to undertake its businesses and activities in accordance to this license and those provisions.

## **Article Four**

This resolution shall be effective from the date of its issuance and shall be published in the Official Gazette.
